This forward-thinking document ensures that Haverford remains a vibrant place to live, work, and play, while also strengthening grant applications to fund these exciting projects.

Commissioners elect their own President and Vice President at the beginning of each new year. The Commissioners appoint a Township Manager who oversees daily operations and a sizable staff.

Regular meetings of the Board of Commissioners are held the 2nd Monday of each month at 7:00 p.m. The Commissioners frequently communicate with their constituents through emails and social media. Please contact them directly to receive their communications as well as up to date information about your ward.

Meetings are broadcast live on the Township Cable Network (channel 38 on Verizon and channel 5 on Comcast) and replay everyday at 9:00 a.m. and 7:00 p.m.

In surveys and public meetings, 24% of respondents identified trails as their mostused recreation spaces. Popular trails like the Darby Creek Trail and Pennsy Trail were noted for their accessibility and natural beauty.

Feedback highlighted a strong desire for more trails, better connectivity, and enhanced trail amenities like signage and shaded rest areas. Residents also emphasized the importance of linking neighborhoods, parks, and local destinations with safe biking and walking routes.

As you may know, Haverford Township is already making strides to meet these goals. Recent extensions to the Darby Creek Trail have provided new opportunities for outdoor exploration, while new sections of the Pennsy Trail are paving the way for expanded connectivity.

The PROS Plan suggests the need for further expansion of both the Pennsy Trail and the Darby Creek Trail, in addition to considering sidewalk connectors to improve pedestrian safety. These conceptual projects have the potential to connect key community hubs like schools and transit stations.

With the 2024 PROS Plan as our guide, Haverford Township is building a future where trails and open spaces bring our community closer together. Let's keep moving forward one step, one trail, one connection at a time!

Understanding Carbon Monoxide: Safety Tips for Your Home Carbon monoxide (CO) is a hazardous, invisible gas that is colorless and odorless, produced by the incomplete combustion of fuels such as gasoline, wood, coal, natural gas, propane, oil, and methane. Homes can be at risk if heating and cooking appliances that rely on these fuels are not properly maintained.

Here are essential tips to protect your household from carbon monoxide exposure:

1. Install CO Alarms: Place carbon monoxide alarms in a central location outside each sleeping area and on every level of your home. For enhanced safety, interconnect the alarms so that when one sounds, they all do.

2. Follow Placement Guidelines: Adhere to the manufacturer's instructions regarding the placement and mounting height of the alarms.

3. Responding to an Alarm: If your CO alarm goes off, evacuate the building immediately and go to fresh air—outside or near an open window or door. Ensure everyone is accounted for and call for help from this safe location, remaining there until emergency responders declare it safe to return.

By following these safety measures, you can significantly reduce the risk of carbon monoxide poisoning in your home. Stay safe and vigilant!

### Investing in Our Future: The 2025 Operating and Capital Budgets

At its December 9, 2024 public meeting, the Board of Commissioners passed the 2025 Operating and Capital Budgets.

Haverford Township is fortunate to have a loyal and hardworking staff of employees and volunteers that continue to provide toptier services to our residents, visitors and businesses. But like any other organization, public or private, the Township also faces a tight labor market and inflationary costs. With over 75% of our budget comprised of labor costs, debt service and insurance premiums – areas that are very difficult to trim without impacting services - our other operational costs are generally very lean. To ensure we continue meeting the high expectations of our community, the adopted budget includes a slight increase to the Township property tax rate from 4.395 mills to 4.545 mills and to the sewer rate from \$4.65/1,000g of water used to \$5.15/1,000g of water used. The 2025 trash and recycling fee will remain unchanged at \$283 per residential unit.

Tax increases are never easy, but they play a pivotal role in ensuring Haverford Township remains the vibrant, thriving community we all love. The Township works diligently to manage annual cost increases, while still delivering the variety and quality of services that make our community a special place to live, work, and grow.

- Renovations to the Skatium locker rooms
- Installation of solar panels at the Township Administration building
- Enhanced pedestrian improvements across the Township
- Finalization and implementation of the new comprehensive plan
- Ongoing investment in sanitary and storm sewer systems

#### Reminder To All Business And Rental Property Owners!!

The Township has a business privilege and mercantile tax for all businesses (including rental property owners) operating in Haverford Township. This is a gross receipts-based tax based on receipts from the previous calendar year. Please visit the Township website for further information and contact the Township's appointed collector, TriState Financial Group at 610-270-9520 with any questions or to resolve any delinquencies. #### Happy Anniversary Haverford Township Historical Commission & Grange Estate

2025 marks the 15-year anniversary of the Haverford Township Historical Commission, which was established by the Board of Commissioners in January 2010 following passage of the Historic Preservation Ordinance. The ordinance recognized that, "The preservation and protection of historic resources are public necessities and promote the health, safety and welfare of the citizens of the Township of Haverford." The goal of the ordinance is to protect those resources, "that have a distinctive character recalling the architectural, residential, commercial, aesthetic and historic heritage of the Township."

More than 100 historic sites identified in a 1994 survey of the Township are now officially listed in the Haverford Township Historic Resources Survey. Additional resources were added in 2021 with funds from a Pennsylvania Historical and Museum Commission grant.

Change is necessary and inevitable for any community to thrive. The goal of good preservation planning is to manage that change to preserve what we value in our Township. Working with property owners to manage that change remains the Commission's ongoing mission.



In May 1974, Haverford Township purchased the Historic Grange Estate, saving it from auction. The estate's history dates back to 1682, when it was bought by Henry Lewis from William Penn. Over time, notable figures like George Washington and Ben Franklin visited the estate, contributing to its rich legacy. The Township just celebrated the 50th anniversary of its acquisition.

#### Smart Disposal: Reduce, Reuse, Recycle and Compost

In today's world, rethinking your waste disposal habits is vital. Many items can be reused, repurposed, recycled, or composted to help reduce landfill waste. Here's a quick guide to help you make smarter disposal choices:

#### Reduce

- Mindful Purchasing: Choose durable, highquality products to minimize the need for frequent replacements & only buy what you need
- Refillery Shopping: Bring your own containers to refill soaps, detergents, sunscreens, etc.
- Use Rechargeable Batteries: They're costeffective and help decrease waste over time

#### Reuse

 Electronics: Donate working flat-screen TVs (40" or less) and other electronics to organizations like GreenDrop

#### Recycle

- Batteries (alkaline, rechargeable, Li-ion): Staples
- Small Electronics/Cords/Cables: E-waste bins at Township Building and CREC
- Glass: Drop off at the Township Building to recycle into new glass products or place curbside to repurpose as landfill cover
- Textiles: Donate clean and odorless clothes, shoes, and stuffed animals to Helpsy
- CFL bulbs / fluorescent tubes: DelCo Household Hazardous Waste events

#### Compost

- Curbside Collection: Sign up for bi-weekly food scrap collection and enjoy four months free (thanks to a USDA grant)
- Backyard Composting: Afte training, get a subsidized bin for \$30 (thanks to a USDA grant)

#### Reminder about Pool Water

The Pennsylvania Department of Environmental Protection prohibits the discharge of pool water into storm sewers, even if the water has been dechlorinated. Instead, pool water, chlorinated or dechlorinated, should be slowly discharged to your lawn or another pervious surface on your own property. There are significant fines and penalties if pool water is discharged into the street/storm sewers.

#### Community Development Block Grant Program

What is Fair Housing? Fair housing is the right to choose housing free from unlawful discrimination. Federal law protects people from discrimination in housing transactions such as rentals, sales, lending, and insurance. Fair Housing is the key to all people having the roof they want over their heads.

Who is Protected? The Fair Housing laws protect discrimination on the basis of age, race, religion, ethnicity, national origin, gender/sexual orientation, disability or familial status. Familial status protects discrimination against families with children from being denied housing. These are known as Protected Classes.

What is Prohibited? In the sale and rental of housing, it is illegal to take any of the following actions based on a protected class:

- Refuse to rent or sell housing,
- Make housing unavailable,
  Set different terms or conditions,
- Falsely deny that housing is available.

In mortgage lending, no one may take any of the following actions based on a protected class:

- Refuse to make a mortgage due to your protected class status,
- Set different terms and conditions,

• Discriminate in appraising a property.

#### Protect Your Home: Don't Let Sewer Backups Drain Your Wallet!

Sewer backups and flooding can cause devastating property damage and are not covered by standard homeowners' insurance policies. The majority of these claims are the responsibility of the property owner.

Sewage from sanitary sewer lines occasionally back up into houses through drain pipes. These backups not only cause extensive water damage that is difficult and expensive to repair, but also creates health hazards.

Haverford Township is not responsible for damages caused by sewers, drains and sump pumps except under limited/special circumstances provided by the PA Municipal Immunity laws.

Township residents should review their homeowner's flood and sewer backup insurance coverage with their agent/insurance companies in order to properly protect their personal residence probably the most valuable tangible asset that we all have.

Article I, Section 149-3, subsection C (2) Sewer Service Regulations of the Township Code states that all sewer service laterals connected to the Township system, regardless of location, are the property of the customer and/or owner and shall be maintained by him in good condition and repair. Please pay particular attention to the following coverages:

<u>Coverage for Sewers, Drains and</u> <u>Sump Pumps:</u> This valuable coverage is not included under your standard homeowner's policy but can be purchased by endorsement for an additional premium.

<u>Flood Coverage</u>: Flood coverage is not included under your homeowner's policy. However, flood insurance is available under the National Flood Insurance Program (NFIP) and can be obtained through your insurance agent or broker.

The Township does not provide flood insurance.
